5. Here is a photograph of an unidentified female (50 yrs) dead body which was found at Beldanga PHC, Murshidabad, PS Beldanga, Dist Murshidabad. This refers to Beldanga PS UD c/no 4 dt 18.03.02.



6. Here is a photograph of an unidentified male dead body aged about 40 years was found lying inside a ditch by the Eastern side of Jessore Road near at Buluigachi under PS Habra, District North 24-Pgs. This refers to Habra PS c/no 105 dt 13.05.02 u/s 302/201/34 IPC.



7. Here is a photograph of an unidentified dead body of a male person aged about 30 years who was admitted at Asansol SD Hospital with head injury and expired. This refers to Asansol (S) PS UD c/no 173 dt 06.06.02.



8. Here is a photograph of an unidentified dead body of a Nepali male aged about 25 years was seated in a back side of the Jeep. On way the said person fell down from the Jeep on pacca road and sustained bleeding injury on his person and shifted to Hospital where he expired. This refers to Birpara PS c/no 43 dated 12/6/02 u/s 279/304A IPC.



9. Here is a photograph of an unidentified dead body of a male aged about (40/42) years was found lying dead in a bush with multiple sharp cutting injuries on head near at Foremans Colony Rly. Qtr. No 160 under PS Bizpur, District North 24-Pgs. This refers to Bizpur PS c/no 83 dt 29/6/02 u/s 302/201 IPC.



10. Here is a photograph of an unidentified dead body of a Hindu male aged about 32 years was found lying dead at a vacant land of one Mobarak Hossain at Sikatobagan under Airport PS, District North 24-Pgs. This refers to Airport PS c/no 101 dt 11/8/02 u/s 302 IPC.



11. Here is a photograph of an unidentified dead body of a female aged about 35 years was found lying dead in the open field near Ukhra, Anandamore at the Eastern side of Chandhani Dangalpara under PS Andal, District Burdwan. This refers to Andal PS c/no 119 dt 01/08/02 u/s 302/201 IPC.



12. Here is a photograph of an unidentified dead body of a male aged about 35 years was found lying dead in the Arohar Plantation at Manigram under PS Sagardighi, District Murshidabad. This refers to Sagardighi PS c/no 127 dt 03/12/02 u/s 302/201/34 IPC.

PART - III

Peculiar Modus Operandi.

1. One Saiful Rahaman Bajari, Branch Manager of Mollobhom Gramin Bank, Durlavpur Branch complained that in 1999 and 2000, loan of Rs. 12,73,500/- was sanctioned to one Swapan Mandal s/o Sujit and Suman Das s/o Hemanta both of Hilview, Asansol by the said bank against Postal Certificates, KVPs, NSCs, etc issued from Burnpur PO, Burdwan. On 28/6/03 he went to Burnpur PO to encash the matured KVPs and NSCs Certificates and it was ascertained from the Post Master that those certificates were forged. The accused opened SB Account in the Bank as per introduction of one Niranjana Lohar of Nandanpur, PS Gangajaghati. This refers to Gangajalghati PS c/no 25 dated 8/7/03 u/s 468/469/471/420/407/120B IPC.
2. One Shri Utam Kr. Dey, Dy. Jailor Basirhat Sub-Jail complained that one Kashinath Mandal s/o Harendra Mandal of Laskarnagar, PS Hasnabad, an UTP in c/w SC c/no 27(6)03 was in the custody of Basirhat Sub-Jail. He was scheduled to be produced before the Court on 3/7/03 but he was not produced and next date of his production was fixed on 17/7/03. On 4/7/03 said accused produced an order sheet of Ld. CJM Barasat indicating that he has been granted bail by Ld. CJM Barasat. But on suspicion it could be ascertained that Ld. CJM Barasat did not issue any such order of release and the documents produced are forged and fraudulently obtained. So he was not released. This refers to Basirhat PS c/no 186 dated 12/07/03 u/s 468/471/473 IPC.
