(A) Persons wanted.

1. Accused persons Suresh Kumar Gupta (32) and Ashoke Kumar Gupta (39) both s/o Sri Ram Kumar Gupta of Khairthal Mandi, PS Khairthal, District Alowar (Rajasthan) are wanted in c/w Sonarpur PS Case No 444 dated 23/12/2003 u/s 406/420 IPC, who cheated cash Rs 15 lacs (approximate) from one Ranjit Ganguly s/o Lt Nirapada Ganguly of Garia Station Road, PS Sonarpur, District South 24-Pgs on condition to pay interest @ 4% per month after making agreement on the stamp paper but after giving the interest Rs. 60 thousand on the next month, both the above noted accused persons fled away and evading police arrest.

3. A criminal case vide FIR RC SID 2005 E 003 New Delhi has been registered against Shri Baij Nath Aryan s/o Late K C Aryan r/o House No 2009, Sector-4, Urban Estate, Gurgaon, Haryana u/s 411 IPC, Section 25(2) r/w Section 14(3) AAT Act, 1972, on 7/4/05 in the wake of seizure of 219 registrable antiquities suspected to be stolen from their possession. The details of these suspected antiquities are suspected to have been stolen from some ancient temples, Monuments, achieves, Museums, sites of Excavation etc.

A reference has been made to the Director General, Archaeological Survey of India, Janpath, New Delhi for physical inspection of the suspected antiquities and their opinion u/s 24 of AAT Act, 1972 with regard to its antique nature.

The possibilities of these items being stolen from places of Archaeological importance can not be ruled out. There also be a possibility that some of the seized objects might have figured in some criminal case registered under your jurisdiction.

It is therefore, requested that necessary directions may kindly be issued to the concerned officers under your charge to check up their records and find out if any of the above mentioned object is wanted in any of the case of the theft reported to their police station. And if so, necessary details of the case, description of items stolen and the suspects apprehended etc may kindly be furnished to the undersigned to enable to make further probe into the matter.
