1) On 28/06/2007 Smt. Vijayasree Voora, wife of the petitioner brought her son Aditya from USA to India informing the petitioner that she will be residing with her parents in Chennai but thereafter her whereabouts alongwith the son Aditya are not known.

A cash reward is being declared in this matter to be paid to the person who provides any personal information about the present whereabouts of the said Aditya Chandran and Smt. Vijayasree Voora leading to their recovery. The identity of the informant would be kept secret.

In order to trace the missing Aditya Chandran and Smt. Vijayasree Voora Look out Notices are required to be issued to seek co-operation of the general public/police.

It is, therefore, requested that all the District Police Heads working under your jurisdiction may kindly be directed to circulate the Bio-Data along with photographs of the said lady and her son (enclosed herewith) in their respective jurisdiction to seek co-operation of the general public in tracing them.

(2) Ref: Memo No. 709/C dated 28/10/2009 of Superintendent of Police, Darjeeling in c/w Sadar PS (Darjeeling) Case No. 20/09 dated 08/03/2009 u/s 406/420 IPC.

On 08/03/2009 , one Prashant Thapa of Pusimbong Tea Estate , PS- Jorebunglow, District-Darjeeling lodged a written complaint that as per advertisement regarding -job published by one Amardeep Singh Honija (accused) in local newspaper on September,2008 (Himalayan Darpan) along with placement agency named as “Diya Overseas” situated at Toongsoong, Darjeeling , said Amardeep Singh conducted an interview in Kolkata. The complainant along with other candidates attended that interview. The said Amardeep Singh asked them to pay some amount as an advance and he had promised to provide jobs for them at Macan. Accordingly the complainant along with other candidates gave him (accused) money amounting to Rs.2,50,000/- each. The complainant along with others had been to Bangkok (Capital of Thailand) on 05/10/2008. On reaching there they found some other candidates who were also cheated and they came to know that said Amardeep Singh Honja totally misguided them and failed to provide job. On 09/01/2009 they returned back at Darjeeling and there was no trace of accused Amardeep Singh Honja. The complt. Also alleged that Mrs. Bandana Singh Honja, wife of Amardeep Singh Honja (accused) was also involved and misguided the candidates. During investigation the said accused Amardeep Singh and his wife Mrs. Bandana Singh who were reportedly staying at Toongsoong, T N Road, Darjeeling in the rented house of Smt. Tshring Yeangzan could not be traced, and no other details regarding the accused persons could be cattered .

- 2) On 15/10/09 around 17.15 hrs, 4 unknown miscreants boarding 2 motor cycles, snatched away one Bag containing cash Rs.4,26,000/- and one cheque of Rs.45,000/- of Axis Bank at the point of fire-arms from the possession of one Debabrata Roy of Basantapur PS Jamalpur on way between Chouberia Bridge and Sarangpur Battala. This refers to Jamalpur PS Case No 122 dt 17/10/09 u/s 392 IPC & 25/27 Arms Act
- 3) On 15/10/09 around 02.45 hrs, 6/7 unknown miscreants at the point of firearms looted away 8/9 bhories of gold ornaments (approx), cash Rs.15,000/-, 3 Nos of Mobile phones and one Titan wrist watch etc. from the house of one Sunirmal Mondal of Shibrampally, Mangalbari. This refers to Malda PS Case No 222 dt 15/10/09 u/s 395 IPC.
- 4) On 20/10/09 around 13.30 hrs, 30/35 Arms CPI (Maoist) led by Sasadhar Mahato, Suchitra Mahato, Jagari Baskey and others came by motor cycle and entered into Sankrail Police Station by overpowering on duty sentry and started firing upon SI Dibakar Bhattacharjee and ASI Swapan Kr Roy resulting their instant death at the spot. The Maoists also looted away 180 rounds of .303, 72 rounds of .38 and 30 rounds of .9 mm ammunitioins, 2 DBBL and 7 SBBL Guns, 3 Revolvers and one Pistol from Malkhana and Armoury and kidnapped one SI Atindra Nath Dutta, O/C Sankrail PS. This refers to Sankrail PS Case No 70 dt 20/10/09 u/s 147/148/149/364/396/121/ 121A/122/123/124A IPC.
- 5) On 18/19-10-09 night, one Truck no WB-41D/1864 started for Memari from Dantan Check post loaded with Onion. On way about 7/8 Km away from Kharagpur Fly over on NH-6 towards Kolkata one unknown truck stopped the said truck and 5 unknown miscreants came down from the truck and hijacked the said Onion loaded truck on the point firearms. The miscreants took away the khalasi-Jasimuddin Mondal to roadside Bush and fired upon him causing severe injury on his person. Then they took away the driver towards Dantan side and murdered the driver Ratan Hansda by gun shot and sharp cut weapon and dropped his dead body by the side of Dantan Road near Makrampur. This refers to Narayangarh PS Case No 101 dt 19/10/09 u/s 396/412 IPC & 25/27 Arms Act.
- 6) On 20/10/09 around 15.00 hrs, 3 unknown Co-passengers snatched away cash Rs.3 Lacks from the possession of one Shib Prasad Ghosh of Maheshpur PS English Bazaar on way after crossing Sova Nagar after assaulting him while he was travelling by Ambassador No WB-02/0203. This refers to Ratua PS Case No 433 dt 20/10/09 u/s 392 IPC.
- 7) 20/10/09 around 22.00 hrs. 15/20 unknown miscreants being armed with improvised fire arms entered into the house of one Akshay Kr. Das of Kushida Paschimpana and looted away Cash Rs. 1 Lac (approx), some gold ornaments and one Nokia Mobile Phone after assaulting the inmates of the house and also exploded Bombs. This refers to Harishchandrapur PS case no. 260 dt. 21/10/09 u/s 395/397 IPC, 25/27 Arms Act & 3 / 4 E.S Act.

- 8) On 20/10/09 around 13.30 hrs 4 unknown male and one (1) female (suspected to be Maoist Activities) armed with Revolver, Pipe gun and Rifles entered into SBI Kesiapata Branch, forcibly fired 3 rounds from their fire arms aiming to the Bank Staff and looted away around Cash Rs. 9,51,000/- at the point of gun and fled away towards Kesiapata Market by Motor Cycle. This refers to Sankrail PS Case No. 71 dt. 21/10/2009 u/s 395/397/307 IPC & 25/27 Arms Act.

iv) Acting on a secret source information a raid was held on 05/11/09 at around 12:35 hrs at Gorpa crossing near Lake Land Country Club under P.S. Jagacha Dist. Howrah by officers & men of S.O.G. unit CID under the leadership of S.I. Tathagata Pandey and arrested 3 (three) accused persons namely (1) Mikhail S.K. (19) s/o Lt. Marirul S.K. of Vill – Jod Bishnathpur, P.O. – Khamda, P.S. – Raghunathganj. Murshidabad (2) Goutam Mondal (22) s/o Malin Mondal of Vill – Narukhakhichar P.O. – Khamda P.S. Raghunathganj, Murshidabad (3) Ratan Mondal (24) s/o Kokil Mondal Vill - Narukhakhichar P.O. – Khamda P.S. Raghunathganj, Murshidabad and recovered Rs. 94 thousand of FICN of denomination Rs. 500/- (75 Pc) and Rs. 1000/- (19 Pc) also seized one red colour Honda Motor cycle. On the basis of the written complaint Jagacha P.S. case No. 315/09 dt. 05/11/09 u/s – 489B/489C/120B IPC has been started .

v) On 18/11/2009 at 16:20 hrs Officers and men of POWC and other cells held raid at Rajmahal Hotel situated by the side of NH-41, Uttarkasimpur village under PS Mahishadal, Purba Medinipur and rescued 4 victim girls and arrested two accused persons, viz 1) Chittaranjan Jana (52) s/o Panchanan Jana, PO-Keshabpur, Jalpai, PS-Mahishadal, Purba Medinipur 2) Ananda Mal (22) s/o Shri Balia Mal of Narkelda, PO Hasna, PS-Moyna, Purba Medinipur. This refers to Mahishadal PS Case No. 171 dated 18/11/2009 u/s 363/366A/372/34 IPC r/w 3/4/5/6 of ITP Act.

vi) One Nakul Bera s/o Lt. Anadi Bera of Uttarkasimpur, PS-Mahishadal, Purba Medinipur, is the most wanted criminal in some cases controlled by CID and so many Warrant of Arrest pending against him in connection with so many CID controlled cases. He is the king pin of brothels running by the side of Haldia road in Purba Medinipur and an exploiter in the field of human trafficking. AHTU CID was tracking this criminal through various sources. Finally analyzing this source informations, AHTU CID was able to fix his location and whereabouts and on 27/11/2009 informed precisely in the Ld. ACJM Court, Baruipur and informed Superior officers accordingly. On the basis of that secret information he was apprehended by Baruipore PS Police on 27/11/2009 while he was returning from the Court. He was an owner of brothels in Purba Medinipur and procured girls through trafficking agents by deceitful means. Since 5/6 years, he was the key person who ran brothel in that district. It is an achievement of AHTU, CID that he is apprehended at last and it will help to curb down human trafficking in the said district.

vii) On 18-11-09 a team of CID officers, went to Uttar Kashimnagar, Uttar Mashisadal PS, Purba Medinipur and conducted raid at Hotel Styled as "RAJ MAHAL" situated on the north side of NH-41. NGO (JUSTICE & CARE) also accompanied the team after forming a decoy construction. In course of raid two persons namely Chittaranjan Jana and Ananda Mal were arrested on the charge of kidnapping minors and confining them for commercial sexual exploitation. Four victim girls were rescued and on the basis of Suo-Moto complaint Mahisadal PS Case No. 171 dt. 18-11-09 u/s 363/ 366A/ 372/ 34 IPC and 3/ 4/ 5/ 6/ 7 ITPA has been started.

viii) On 12/11/2009 one Bipul Kar S/o- Chandi Charan Kar of 15, Ramcharan Pally, Masterpara, PS.Uttarpara, Hooghly, opened a missing file at MPB, CID, vide No-55/2009/5/F(20) dated 12/11/2009, stating history of missing of his wife Maya Kar (37) from his house on 02/11/2009. In course of enquiry, all the messages received at MPB CID, after 02/11/2009 were scanned as per my instruction, to find resemblance in descriptive roll. The message of Polba PS. dated 03/11/2009 was found out and proximate similarity was observed with the description of the dead body and description noted in missing file. Photographs of the corpse was collected from O/C Polba PS., that was shown to Bipul Kar who identified the same as his wife, Maya Kar. This is a good work executed by the MPB CID with sincere effort and perseverance.

ix) In course of investigation into Raghunathganj PS Case No. 435 dated 27/08/2009 u/s 395/397/412 IPC & 25/27 Arms Act, officers of DRBT Cell, CID, WB led by Inspector S.K.Halder, O/C DRBT Cell, CID, West Bengal secured the arrest of accused persons namely 1) Asraf Sk @ Bhola s/o Lt Kausar Sk of Kanupur Mathpara, PS-Raghunathganj, Murshidabad 2) Bablu Mashi @ Mechia s/o Pradip Mashi of Laharatara PS-Madhuyadhesh, District-Benaras, Uttar Pradesh A/P c/o Tashu Sk of Palsa, PS-Murarai, Birbhum and 3) Ananda Dhar @ Manager Master @ Masterda (46 years) s/o Lt Sasthi Charan Dhar of Rabindrapally, PS-

Raghunathganj, Murshidabad on 06/11/2009, 07/11/2009 & 08/11/2009 respectively, which led to the recovery of looted cash Rs.3,00,000/- (Rupees three lakhs) from the house of accused Asraf Sk @ Bholra on 07/11/2009 and thereby detected the case.
