#### **(A) Persons wanted.**

DGP, Bihar, Patna Org No 43/NGO Patna dated 26/09/06 u/s 457/380 IPC, 18 bronze Idols have been burgled from Patna Museum on the weight of 24-26/09/06. The case being of National importance, all help may be rendered for recovery of stolen Idols as well as the apprehension of the culprits and if traced, DGP Bihar, Patna be informed immediately under intimation to the office of the Special Superintendent of Police, CID, West Bengal, Bhabani Bhaban, Alipore, Kolkata – 700 027.

Brief description of Idols are as under

1) LOKENATH - SEATED IN LALITASAN ON DOUBLE LOTUS SEAT PLACED ON HIGH TRIRATHA PEDASTAL. RIGH HAND IN VARADMUDRA, THE LEFT CARRIES LOTUS STALK. RIGHEIGHT PENDANT LEG IS BROKEN AND MISSING, DRAPERY OF DHOTI UNDER LEFT LEG: NO LOOSE END IN CENTRE. LOTUS FLOWER SLIGHTLY RAISED TURNED UPWARDS. HEIGHT 30CM. HEIGHT WITH HALLOW 39 CM. EARLY 11TH CENTURY A.D.

2) BUDDHA -STANDING IN SAMAPADASTHANAKA RIGHAND IN ABHAYA MUDRA AND END OF GARMENT IN LEFT HAND. HEIGHT 20 CM 9TH CENTURY AD.

3) BUDDHA - SEATED IN BHUMISPARSHA MUDRA. SILVER EYES, LOWER COPPER LIP SEAL ON BACK, HEIGHT 23.5 CM. 10 CENTURY AD.

4) MANJUSRI - BUDDHA STANDING ON A SINGLE LOTUS PEDASTAL WITH RIGHT LEG SLIGHTLY BENT FORWARD AND LEFT HAND PENDENT AND HOLDING STALK OF NILOTPALA ISSUING FROM PLANT WITH ROOT SCROLL ON LEFT SIDE. NECKLACE WITH ARMLETS DHOTI WITH ALTERNATING BANDS OF SILVER AND COPPER. HORSE SHOE SHAPED PRABHAMANDALA WITH FLAME EDGE. TRIANGLE ON TOP. HEIGHT 17 CM 10TH CENTURY AD.

5) BUDDHA SEATED IN BHUMISPARSHA MUDRA ON A SINGLE LOTUS SEAT PLACED ON A SIMHAVASANA IN A MASSIVE TREFOIL NICHE, SUPPORTED BY PILASTARS. TWO LIONS ON RIGHT AND LEFT OF TRIRATHA PEDASTAL, LOWER LIP COPPER, HEIGHT 14.5 CM 10<sup>TH</sup> CENTURY AD.

6) MATREYA STANDING ON A SINGLE LOTUS SEAT FLOWER IN LEFT HAND, RIGHT HAND PENDANT WITH VARADAMUDRA. STUPA IN JATAMUKUTA ABHAMANDALA AROUND THE BODY. HEIGHT. 20.5 CM. 9TH CENTURY AD.

7) VASUDHARA SEATED IN LAUTASNA ON SINGLE LOTUS SEAT PLACED ON TRIRATHA PEDASTAL. LEFT HAND HOLDS STAFF WHICH HAS FOUR ENDS AROUND WHICH A THIN WIRE ENTWINED. A BOYS FIGURE ON A SEPARATE PROJECTION ABOVE ON SEAT. FIGURE HOLDS HIS LEFT HAND INTO A POT. IN HIS RIGHT HAND A ROUND OBJECT. THRONE CORRODED. A KNEELING DEVOTEE IS ON LOWER RIGHT CORNER OF PEDASTAL HEIGHT. 21.5 CM. 935 AD.

8) RECTANGULAR PEDASTAL WITH 4 FIGURES SEATED IN MAHARAJALILA FROM LEFT TO RIGHT 3 DEVI WITH CHILD ON LAP. FRUIT IN RIGHT HAND HCM. 10TH CENTURY AD. . HEIGHT. 6.2 CM, LENGTH 11 CM 10<sup>TH</sup> CENTURY AD.

9) CROWNED BUDDHA ON DOUBLE LOTUS PEDASTAL RIGHT SIDE BROKEN. STANDING ON LEFT HOLDING THE END' HAND IN VARADAMUDRA BOTH SHOULDERS, SILVER EYES NOSE PENDANTS OF HARA LOTUS MARKS ON HAND, HEIGHT 35 CM 11<sup>TH</sup> CENTURY AD.

(10) TARA STANDING IN SAMAPADASTHANAKA ON LOTUS SEAT PLACED ON TRIRATHA PEDASTAL. HER RIGHT HAND IS IN VARADAMUDRA AND LEFT

HOLDS STOCK OF LOTUS WITH 2 FEMALE ATTENDANTS LEGS OF BOTH ATTENDANTS BROKEN BUT JOINED. BREAST DECORATED WITH CREEPER DESIGN INCISED ATTENDANT HAVE SHORT LOIN CLOTH, SILVER TITAKA ON FOREHEAD. HEIGHT 36 CM. 10TH CENTURY AD.

(11) SIMHANADA AVALOKITESVARA SEATED IN LALITASNA ON LION. LEFT HAND STRETCHED DOWN AND CARRIES LOTUS STALK. LOTUS FLOWER UPTURNED WITH HILT OF SWORD. RIGHT HAND PENDANT ON RIGHT LEG. THIRD EYE MARKED ON FOREHEAD. HEIGHT. 17.5 CM. 11<sup>TH</sup> CENTURY AD.

(12) SYAMATARA SEATED IN ARDHAPARYANKASANA ON A DOUBLE PETALLED LOTUS SEAT PLACED ON A SIMHASANA WITH HER RIGHT LEG PENDANT WHICH RESTS ON A SMALL LOTUS IN FRONT HER RIGHT HAND IS IN VARADAMUDRA WHILE THE LEFT CARRIES A LOTUS STALK. SILVER EYES, HEIGHT 29.5 CM, HEIGHT WITH HALO 32 CM. EARLY 9TH CENTURY.

(13) BUDHA IN BHUMISPARSHA MUDRA- EYES URNA INLAID WITH SILVER SEATED ON DOUBLE PETALLED LOTUS SEAT ON A RECTANGULAR PEDASTAL. 3 UONS ARE NOTICED IN FRONT OF PEDASTAL. 2 DEVOTEES IN KNEELING POSTURE, HEIGHT. 30 CM. 10TH CENTURY AD.

(14) BUDHA SEATED IN VAJRAPARYANKASANA, RIGHT HAND IN VARADAMUDRA WITH OVAL OBJECT IN IT LEFT HAND IN LAP AS ASUAL JEWEL DEVICE ON TOP OF CHHATTRA. RIGHT HALF OF PEDESTAL MISSING HEIGHT 15 CM 11<sup>TH</sup> CENTURY AD.

15) BUDHA BHUMISPARSHA MUDRA ON SINGLE LOTUS INVERTED SEAL PLACED IN RECTANGULAR PEDASTAL BODHI TREE LEAVES AFIXED IN INTERIOR. HEIGHT. 18 CM. 9TH CENTURY AD.

(16) TARA 8 ARMED WEARING A HIGH JATAMUKATA AND SEATED IN SUGHT BHANGA ON HIGH STALK WITH ROOT SCROLL RISING FROM PEDASTAL, RIGHT LEG PENDANT ON SEPARATE LOTUS. RIGHT HAND HOLDS TRISULA, CHAKRA, KHADGA, VARADA WITH POINTED FRUIT ON PALM. HEIGHT. 37.5 CM. 11TH CENTURY AD.

(17) BUDHA SEATED IN BHUMISPARSHA MUDRA RECTANGULAR PEDASTAL WITH INSCRIPTION. TWO LINKS COVERED BY FOUR PETAL LOTUSES BETWEEN SOLDIERS OF BUDDHA AND RIM. BODHITREE BRANCHES FALL OVER RIM TO 60TH SIDES OF SHAFT OF UMBRELLA ON TOP. HEIGHT. 22.5 CM. 9 TH CENTURY AD.

(18) BUDHA IN BHUMISPARSHA MUDRA ON A LOTUS SEA.T PLACED ON AN ORNATE PEDASTAL BACK OF THRONE OF IMAGE OF 14 UON & ELEPHANTS AS USUAL. ITS INTERNA.L RIM IS BESET WITH OF ROW OF FLOWERY DESIGN WHILE MIDDLE HAS BEAD DESIGN, HEIGHT. 22.5 CM. 9TH CENTURY.
