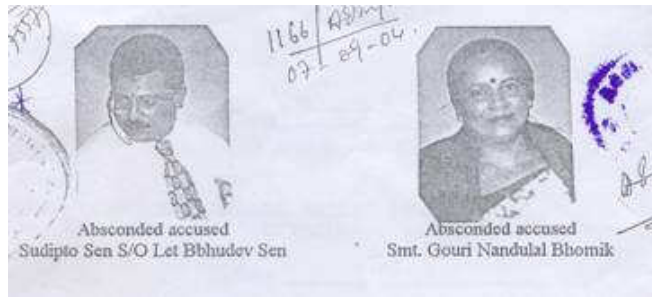
If traced she may be arrested with immediate intimation to the SP CBI, New Delhi for taking necessary action.

It is therefore, requested that necessary directions may be issued to the concerned officers under your charge to check up their records and find out if the above mentioned object is wanted in any case of theft reported to their police station and if so, necessary details of the case, description of the items stolen and the suspects apprehended etc may be furnished to the Supdt of Police, CBI/SPE/EOU-VIII/ New Delhi to enable them to make further probe into the matter.

2. 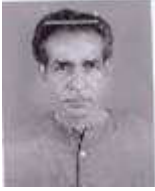
